Gravesham Friendly will be the trading name only and not replace the registered name of Anglo-Saxons

Friendly Society with the Regulators. The exercise has been carried out as a result of consumer feedback that the name was seen as a barrier to recruiting new members and to reflect the strategy to support the Gravesham community and our commitment to inclusivity.



#### **DISCRETIONARY BENEFITS**



A reminder that you can still submit online website claims until Wednesday 20 December. If you have a discretionary benefit claim from late October, November or December, these can be submitted for consideration in January-March 2024 providing they are submitted within 3 months of the treatment date.

We have received several enquiries relating to inputting a member's date of birth on an android mobile phone when submitting an online claim. As you can see from the first image, there are no arrows allowing the user to scroll through the years. To easily access the years, click on the year above the day and date shown on the first image. This will bring up a column where you can easily scroll through the years, as shown in the second image.



#### **DIGITAL CLAIMS**

The number of claims submitted via the website continues to increase on a monthly basis and in November, 59% of claims were submitted via the website. Feedback shows that members appreciate the speed and easiness of this method.
