### **REBRANDING**

At the AGM on 5 May 2023, the Board announced that rebranding would be reviewed at the Board Strategy Day in May 2023. At the Strategy Day it was agreed to consider local agencies to carry out this exercise. Interviews were held and a local agency has been appointed. Initial suggestions have been received and the Board has requested consumer research to be carried out on a selection of the suggested names put forward as possible trading names for the Society.



An email was sent last week inviting you to take part in the survey. Responses are required by 31 October 2023. Your help with this will be greatly appreciated and your views and opinions will be discussed by the Board on 2 November. Anglo-Saxons Friendly Society Limited will remain the official name of the Society but it will be rebranded to 'XXXX and promoted as the trading name of Anglo-Saxons Friendly Society Limited'.

### **CLAIMS PROCESS**

We hope you are finding the online claims process enables you to submit claims quickly and improves our service to you. Thank you to the members who have provided positive feedback advising how quick and easy it is to submit a claim. In 2022, 80% of discretionary claims were submitted via post which reduced to 50% by April 2023. Since the introduction of the online claims system, this percentage has decreased to 29% resulting in 71% of claims being received electronically as at September 2023. Thank you for embracing and supporting the online process which supports our climate change ambition to reduce the use of paper. The target is to achieve 75% of all claims electronically.

However, we apologise to members who have experienced difficulties and thank you for advising of these. The server capacity has been increased to handle the increased volume of online claims and monitoring has also been introduced to alleviate any problems.

If you are unable to submit claims online and are completing forms to submit via email or by post, please ensure these do not have boxes in Section D that are required to be ticked. These forms have now been updated and the latest versions are available to download from the website after signing into your account or can be requested from the office.

### **MEMBER-GET-MEMBER**



You can still earn £50 under the Member-Get-Member scheme that the Board has extended until further notice. The member testimonials show how the Society has helped members over the years and the MGM scheme is an ideal way to introduce family and friends and earn a reward. Since the introduction of the scheme, 40% of new members have been introduced by existing members who have now received their reward for introducing a new member.

### **ASFS EXTRA**

The Mimecast message that appeared on the links of the AS Extra monthly offers has been resolved and members should now be able to click the links without the need to register their details.

The monthly figures for viewers to the website shows that these are steadily increasing and we hope the offers are helping members to save money in the current economic climate.

A page dedicated to ASFS Extra is currently being built into the website and notification of this will be sent to members when it is available.



An analysis of claims shows that to date in 2023, the Society has paid out over £80,000 for optical grants. Please remember that you can claim a free eye test when you spend £50 or more and 30% when you spend £50 or more on glasses, prescription sunglasses and contact lenses\*.
